

Deckorators® Deck Stones Limited Product Warranty

Deck Technologies, Inc. warrants its products to be free from defects in material and workmanship when delivered to its customers. The composite decking elements in the product are warranted against rot, decay and termites for a period of twenty (20) years and against all other deficiencies for ten (10) years from the date of purchase. The granite stone components in the product are warranted against delamination for five (5) years, and all other stone components are warranted for two (2) years from the date of purchase. This warranty is predicated on the condition that the customer applies an appropriate sealer material on the StoneDeck panels, in accordance with the manufacturer's specified recommendations, in order to protect the stone from the effects of weather- and/or chemical-related deterioration.

Deck Technologies, Inc. further warrants that its products conform to the specifications published in its current literature. If a Deck Technologies, Inc. product is defective or does not meet the published specifications, and the customer gives written notice to Deck Technologies, Inc. before installing the product, Deck Technologies, Inc. will replace the product without charge to its customer or refund the purchase price, at Deck Technologies, Inc.'s election. Pursuant to Deck Technologies, Inc.'s directions, such customers shall return the applicable product to Deck Technologies, Inc. or destroy the defective product if so directed. Replacing the product or obtaining a refund are the buyer's sole remedy for a warranty issue. Deck Technologies, Inc. will not be liable for any consequential damage attributed to a defective product. Neither Deck Technologies, Inc. or any of its distributors shall, however, have any obligation to install such replacement product.

This warranty is given in lieu of all other warranties, express or implied, oral or written, and Deck Technologies, Inc. hereby EXPRESSLY DISCLAIMS ALL OTHER WARRANTIES, INCLUDING THE IMPLIED WARRANTY OF MERCHANTABILITY AND THE IMPLIED WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE. There are no other warranties which extend beyond this description hereof.
